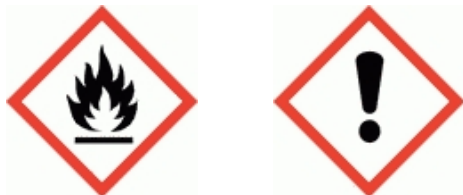

#### **4 FIRST-AID MEASURES**
