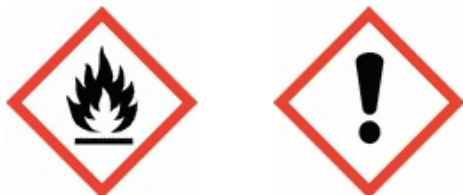

4 FIRST-AID MEASURES

4.1 Description of first aid measures

General information:

5 FIRE-FIGHTING MEASURES

5.1 Extinguishing media

Vapors may cause vomiting and nausea. Wear appropriate respiratory protection.
