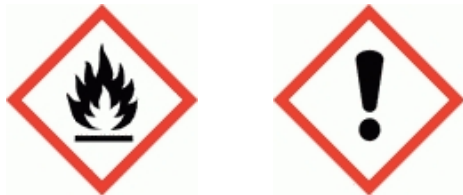

## 4 FIRST-AID MEASURES

### 4.1 Description of first aid measures

General information:
