**Section 4: First Aid Measures**

**If ingested:** NEVER: Give anything by mouth to an unconscious person. Rinse mouth with water. Immediately after ingestion: give lots of water to drink. If victim is alert and conscious; give 2-4 cupful of milk or water. Seek immediate medical attention

## **Section 6: Accidental Release Measures**

---

**Personal precautions, protective equipment and procedures:** Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate protective equipment and clothing during clean-up. Avoid breathing vapors. Ventilate area if easy to do so. Contact local authorities if significant spillages cannot be contained. For personal protection, see section 8 of the SDS. Prevent dust cloud formation, e.g. wetting.

**Containment Equipment and Procedures:** Large Spills: Contain actively spilling material if safe and easy to do so. Dike the spilled material, where this is possible. Utilize absorbent clay or sand to contain and stop spreading material.

Small Spills: Utilize absorbent clay or sand and transfer to waste receptacles. Thoroughly clean surface to remove residual contamination.

**Cleanup Procedures:** Collect all contaminated clay, media, or other cleanup materials into a waste receptacle. If cleaning surface is necessary, utilize mineral spirits or other solvents, provided adequate ventilation is available.

**Safe Handling Precautions:** Do not handle until all safety precautions have been read and understood. Do not handle near an open flame or sources of ignition. Ensure adequate ventilation. Take precautionary measures against static discharges. Avoid breathing vapors. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Wear appropriate personal protective equipment. Thoroughly wash hands after handling.

**Recommendations for Storage:** Store in cool area in product container away from sources of ignition or flame. Avoid flash point temperatures of >200F.
