**Section 4: First Aid Measures**

**Personal precautions, protective equipment and procedures:** Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. **Cleanup Procedures:** Collect all contaminated clay, media, or other cleanup materials into a waste receptacle. If cleaning surface is necessary, utilize mineral spirits or other solvents, provided adequate ventilation is available.

**Safe Handling Precautions:** Do not handle until all safety precautions have been read and understood. Do not handle near an open flame or sources of ignition. Ensure adequate ventilation. Take precautionary measures against static discharges. Avoid breathing vapors. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Wear appropriate personal protective equipment.
