Section 4: First Aid Measures

Notable Exposure symptoms: Dermatitis, rash, severe eye irritation.

Section 6: Accidental Release Measures

Personal precautions and protective equipment and procedures: Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate protective equipment and clothing during clean-up. Avoid breathing vapors. Section 7: Handling and Storage

Take precautionary measures against static discharges. Avoid breathing vapors. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Wear appropriate personal protective equipment.
