Section 4: First Aid Measures

If ingested: Rinse mouth. Immediately after ingestion: give lots of water to drink. Do not induce vomiting. Ingestion of large quantities: seek immediate medical attention

Section 5: Fire Fighting Measures

Extinguishing Method / Equipment: Carbon dioxide (CO₂), dry chemical, foam. Firefighters should wear self-contained breathing apparatus (SCBA) and full protective equipment.

Hazardous Decomposition Info: Constituents associated with burning / CO and CO₂ formed, Reacts with strong oxidizers. Reacts with organic material. Risk of spontaneous ignition.

Section 6: Accidental Release Measures

Personal precautions, protective equipment and procedures: Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate protective equipment and clothing during clean-up. Avoid breathing vapors. Ventilate area if easy to do so. Contact local authorities if significant spillages cannot be contained. For personal protection, see section 8 of the SDS. Prevent dust cloud formation, e.g. wetting.

Small Spills: Utilize absorbent clay or sand and transfer to waste receptacles.

Cleanup Procedures: Collect all contaminated clay, media, or other cleanup materials into a waste receptacle. If cleaning surface is necessary, utilize mineral spirits or other solvents, provided adequate ventilation is available.

Safe Handling Precautions: Do not handle until all safety precautions have been read and understood. Do not handle near an open flame or sources of ignition. Ensure adequate ventilation. Take precautionary measures against static discharges. Avoid breathing vapors. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Wear appropriate personal protective equipment.
