SECTION 5. FIREFIGHTING MEASURES

before breaks and meals, and at the end of each work period. Contaminated clothing and shoes should be thoroughly cleaned before re-use.

In addition, use general dilution ventilation of the work area to eliminate or reduce possible worker exposures.

Protective measures

- : In December 2003, the National Institute for Occupational Safety and Health ("NIOSH") published an Alert on preventing lung disease in workers who use or make flavorings [NIOSH Publication Number 2004-110].
In August 2004, the United States Flavor and Extract Manufacturers Association (FEMA) issued a report entitled "Respiratory Safety in the Flavor Manufacturing Workplace".
Both of these reports provide recommendations for reducing employee exposure and for medical surveillance in the workplace.
