SECTION 4. FIRST AID MEASURES

Environmental precautions : Keep away from drains, surface- and groundwater and soil.

SECTION 7. HANDLING AND STORAGE

Handling : Avoid excessive inhalation of concentrated vapors. Follow good manufacturing practices for housekeeping and personal hygiene.
